You will need to locate the General1.dbf file in the Database directory in order to set the path. Also the path can either end in a backslash as in C:\impro32\dbf\ or not as in C:\impro32\dbf .
- We have added a **Form Page Color** button to the tool palette. This will display the color of each page of the form, so that you will know which color of paper to insert into the printer.
